

# 8.1 REQUEST AUTHORISATION FOR A PLANNING SCHEME AMENDMENT -UPDATE OF ENVIRONMENTAL SIGNIFICANCE OVERLAY SCHEDULE 4

#### Summary

Council received a request from Coliban Water on 28 August 2020 to amend the Macedon Ranges Planning Scheme. The request seeks to amend Clause 42.01 - Environmental Significance Overlay Schedule 4 – Eppalock Proclaimed Catchment (ESO4) and associated changes as described in this report. The amendment is necessary to implement the Upper Coliban Integrated Catchment Management Plan 2019, which has been prepared by the North Central Catchment Management Authority and Coliban Water.

This report seeks a resolution of Council to request authorisation from the Minister for Planning to prepare Amendment C145macr and to proceed to public exhibition.
