

6 PETITIONS

6.1 PETITION IN RELATION TO THE SPEED LIMIT ON SPENCER ROAD, WOODEND

Summary

A petition has been received from Nicholas Martin in Woodend on behalf of 30 residents stating:

"Mayor and Councillors of the Macedon Ranges Shire Council, we the undersigned, petition Macedon Ranges Shire Council as of 1 March 2025 to maintain the speed limit for Spencer Road as a maximum of 50km/h, and move to re-install signage by the end of the month."

7 DEPUTATIONS AND PRESENTATIONS TO COUNCIL

7.1 PUBLIC QUESTION MATTHEW ROBERTS

Question

The Municipal Association of Victoria was concerned that decriminalising sex work would lead to an unmanageable number of complaints about sex work in the first year after sex work was decriminalised in Vic, Macedon Ranges Shire Council received 3 complaints about sex work. Does the Council believe it has enough resources to adequately respond to 3 annual complaints about sex work.

Answer

Thank you for the question. It is useful to reflect on the impact to local government of legislation change.

In the period 01/12/2023 - 01/12/2024, following the decriminalisation of sex work in Victoria, Macedon Ranges Shire Council has received three complaints relating to sex industry businesses. These complaints took an average of one hour each to investigate and resolve.

Council is currently sufficiently resourced across our compliance areas to adequately investigate and respond to complaints relating to sex work.

7.2 PUBLIC QUESTION SUZANNE EREAUT

Question

Can Council justify the increase in animal registration fees by over 12% in a year following a hefty increase last year? I point out that this level of increase is well outside the rate of inflation and well above all other fees levied by Council, I can only view this as a blatant money grab.

Answer

Council charges an animal registration fee to assist in covering the costs of Council's animal management program run by Council. This includes:

- Maintaining dog off leash areas including increased signage
- Supply of dog waste bags in popular dog exercising locations
- Responsible management of dog's campaign for the love of paws
- Active animal management staff to respond to community reports, conducting proactive off leash patrols, and running a 24hr after hours service over 365 days per year
- Free ride home program for lost pets that are currently registered and don't have prior history of escaping or been involved in a dog attack.
- Service, maintain and operate kennelling/cattery facilities and purpose-built ranger vehicles
- Contracted pound services with the Lost Dogs Home for pets that cannot be returned home by officers
- Subsidised programs with discount incentive schemes for new registrations to promote pet adoptions and desexing

Council funds its Animal Management operations through fees, having adopted an educational approach to public dog management, and therefore doesn't rely on revenue from infringements issued to our community.

Animal registration fees are set each year through Council's budget process. When setting fees, Council considers the impact on the community and the sustainability of our services. The review of the fees for registrations reflects consideration of the increased costs to deliver these services. Between 2023 to the current year, all animal registration fees have gone up an average of 14%.

Across all of Council's fees and charges, while many have increased close to 5%, many have gone up by a greater or lesser degree, which reflects the impact of CPI increases, costs of service delivery, and other drivers.

The fees charged reflect the costs of the animal management program and is within the range of like benchmarked Councils.

PE.3 DRAFT KYNETON URBAN DESIGN FRAMEWORK FOR ADOPTION

AO.2 RESPONSE TO PETITION - IMPROVED WILDLIFE SIGNAGE AND SPEED LIMIT REVIEW IN WILDLIFE CORRIDORS

Summary

A petition has been received from Janine McDougall, a resident of Riddells Creek, on behalf of 62 people stating:

"Mayor and Councillors of the Macedon Ranges Shire Council, we the undersigned, petition Macedon Ranges Shire Council, as of Friday September 22nd, 2024, to allocate more funding in the 2024-2025 Council managed roads audit to improved wildlife warning signage, speed limit review with a view to speed reduction in Wildlife prone area, and wildlife corridor feasibility studies."

This report provides an update to councillors on the Council's ongoing and upcoming efforts to improve wildlife safety. It includes consideration of regulatory requirements, technical standards for speed reduction in Victoria, data integration, and the identification of hotspots. The report also outlines the development of a mitigation strategy and emphasises the importance of collaborating with the community and external stakeholders.
