

7 DEPUTATIONS AND PRESENTATIONS TO COUNCIL

Resolution 2022/94

Moved: Cr Rob Guthrie Seconded: Cr Mark Ridgeway

That Council suspends standing orders in order to hear questions from members of the public this evening.

7.1 QUESTION PROVIDED BY MR DALE O'SULLIVAN.

As a result of attending the Shire's highly successful community luncheon at the Woodend RSL recently, I had the pleasure to meet members of our Ukrainian Community.

One thing because very clear they don't want help to become refugees if they lose the war against Russian invasion. They want help immediately to win the war, so as not to become refugees. What a wonderful statement.

In this regard our question is

- What has the Shire Council done so far to fund Ukrain's immediate needs and does Council support them in such a worthy cause, to avoid becoming refugees in the future. At the moment the Shire appears silent on their priorities to self-help.
- Can the Council show more public support such as direct funding donations to Ukraine's official donations office in Melbourne for example. (Details to be supplied if Shire interested)

Answer

At its Scheduled Meeting held in April this year, Council unanimously passed a motion confirming its position of solidarity with and support for the people of Ukraine.

As part of this April 2022 resolution, Council lit up the Kyneton Town Hall in Ukrainian flag colours, committed to provide assistance to Ukrainian refugees seeking shelter in the Macedon Ranges, and publicly expressed its gratitude and thanks to local organisations and individuals aiding Ukrainian refugees.

It's worth noting that Macedon Ranges Shire Council is a Refugee Council of Australia Refugee Welcome Zone, and supports a number of related initiatives, including the Back Your Neighbour campaign and the Macedon Ranges Rural Australians for Refugees (MRRR) committee, who have recently received a grant through our Community Funding Scheme.

The Mayor also advised that she and the CEO met with the Ukrainian ambassador earlier this year.

7.2 QUESTION PROVIDED BY SHAUNA MARTIN

With regards to the Romsey Sporting Precinct Draft plan, why has the Council not incorporated a swimming pool as this is something the community has been requesting during previous community consultations, so is the Council listening to the community?

Answer

The Romsey Sports Precinct Master Plan was originally adopted in 2010. The recent review was held with the current formal users of the precinct. The draft plan is to be considered by Council in today's meeting agenda for release for public consultation. The public will have the opportunity to make comment on the Romsey Sporting Precinct Draft Plan.

Council has heard the community seeking a new aquatic facility in the east. Aquatic Facility Feasibility Study Macedon Ranges Shire Council (East) is one of twelve projects within Council's Priority Project 2022 Prospectus. The prospectus is shared with the Federal Government, Victorian Government and funding agencies seeking funding for a feasibility study. This study will test the current demand for an aquatic facility in the east of the shire in the context of the wider demand and utilisation across the municipality.

Subject to need it will also determine the most appropriate location and enable the development of concept plans to support application for funding of any future construction.

7.3 QUESTION PROVIDED BY CASSY BORTHWICK

Peri urban growth offers a real and current threat to our regional lifestyle, history and future, if not executed with proper care and planning. Here tonight at this meeting have two options; the easy way and the hard way. They easy way is just say yes without pushing for accountability and planning, hope then that all the stakeholders come to the party. The hard, I hope you vote on, is to delay until the required strategic planning, commitment from your state, federal and utility alliances is guaranteed. The decision you make will impact well beyond Romsey - you tonight set the precedent for future towns that are targeted as the 'new peri urban hotspots.

Tonight you have an opportunity to drive realistic, solid, sustainable, courageous change and decision making for the district of Romsey. So my question is how many of you will fight, advocate for the necessary planning, additional time and guarantees from political, utility, developer and community stakeholders to achieve a brave, positive and sustainable outcome for the community of Romsey and beyond?

Answer

This question will be addressed in the response to the next question.

7.4 QUESTION PROVIDED BY MEMBER OF THE PUBLIC

The Romsey EOP structure plan strategy needs to be developed in a way that ensures appropriate services and infrastructure is in place before we increase the population of Romsey. We want to build a sustainable community with a good quality of life for all. What guarantees do the current residents of Romsey have that we will receive the proper investment from the State Government, local government and service providers with this proposed increase in population? What mechanisms and controls for infrastructure and services will be applied before the increase in population?

Answer

The role of a Structure Plan is to set a high-level framework that will include requirements for detailed service delivery plans to be developed. The services required under these plans may be delivered by Council, by the developer or other agencies.

Through the rezoning and planning permit process, state government, agencies and Council have the opportunity to provide comments and conditions relating to adequate infrastructure provision.

7.5 QUESTION PROVIDED BY MEMBER OF THE PUBLIC

The Romsey Emerging Options Paper seeks to endorse the Greater Western Water Sewerage Treatment Plant buffer reduction from 900 metres to 600 metres. Have Councillors been provided adequate research to support this reduction and has this research allowed for any sewerage treatment plant expansion for future population growth?

<u>Answer</u>

The Romsey Emerging Options Paper does not seek to endorse the Greater Western Water Buffer to 600m. The Emerging Options Paper identifies that with adequate modelling and analysis buffers on treatment plants can be reduced to 600m.

The Emerging Option Consultation Report identifies as action 36 to 'continue working with Greater Western Water in finalising the buffer areas around the Romsey Water Treatment Plant to ensure this outcome feeds into the draft Romsey Structure Plan'.

7.6 QUESTION PROVIDED BY DAVID RODDEN

- 1. Are Councillors aware that the resolution before them, to adopt the Romsey Emerging Options Paper Consultation Summary Report, effectively disregards all prior strategic planning, including the Romsey Outline Development Plan November 2009, which provides for two priority future residential areas, including the north east (north of Romsey Road and east of Tickawarra Road)?
- 2. As identified by officers in the Romsey Emerging Options Paper Consultation Summary Report (in the Officer response to 2.9.3 Option 3: East and South Growth), the Emerging Options Paper acknowledges that there are some desirable options for growth to the south and east but also constraints, for some unknown and unexplained reason the Consultation Summary Report then concludes that one growth area should be chosen over another, without any analysis or thorough planning process that would require detailed mapping of opportunities and constraints. This work is the role of the Structure Plan, which is yet to be presented to Council for consideration. In summary, we are seeking confirmation that the Council will ensure that a thorough and proper planning process is undertaken to inform any decision on the growth of Romsey for the next 30 years?

<u>Answer</u>

- The Romsey Outline Development Plan identifies opportunities for further growth (page 65). By endorsing the Romsey Emerging Options Paper Consultation Summary Report, it is acknowledging that the preference is for infill development in the first instance and growth to the south of Romsey.
- 2. The Draft Structure Plan will include proper planning practice to identify the new township boundary for Romsey.

7.7 QUESTION PROVIDED BY HAL PRITCHARD

Given, as stated in the EOP Consultation Summary Report that "The role of the structure plan is not to challenge the settlement strategy but rather to articulate how Romsey will move into its role as a large district town", why are 3 of the 4 population growth scenarios in the EOP significantly above the limit expressly recommended in the Settlement Strategy of "Based on the lack of railway infrastructure, limited community services and concerns regarding existing road infrastructure in comparison to other towns in the Shire, it is recommended Romsey could accommodate a population of approximately 6000 by 2036"? Since the Settlement Strategy in 2011 has there been any significant improvements to the Rail, Road, Public Transport, Education, Health and community services infrastructure that suggests, Council in any good conscience could advocate for a greater population for Romsey than the Settlement Strategy expressly suggests?

Answer

The role of Romsey as a large district town has been identified in state and local policies as a town which can sustain a smaller level of growth compared to the regional centres of Gisborne and Kyneton. The Macedon Ranges Statement of Planning Policy indicates that Romsey will be a 'large district town' with a population between 6000 and 10,000 people. The preparation of the Romsey Structure Plan will identify growth and development for the next 30 years (2050) which extends past that of the Settlement Strategy timeline of 2036.

The options that were presented in the Emerging Options Paper were aimed to stimulate debate and discussion with the community and stakeholders. They were for testing and discussion purposes only. With a current population of 4935 people, all options/growth scenarios provided are with the parameters of a large district town as identified in the Macedon Ranges Statement of Planning Policy.

7.8 QUESTION PROVIDED BY JAMES DIBBLE

- 1. Councillors, are you aware that the Romsey Emerging Options Paper Consultation Summary Report contains actions, notably within Actions 4, 52 and 56, which ,if endorsed, commit Council to directions on the growth of Romsey for the next 30 years in the absence of any detailed planning analysis, and prior to the preparation and consideration of the draft Romsey Structure Plan?
- 2. Will Councillors ensure that the directions for growth are considered as part of a proper planning process which provides for a detailed analysis of all relevant planning considerations, including updated census data, lot supply, growth projections and detailed analysis of opportunities and constraints for all areas including within Option 3 of the Romsey Emerging Options Paper?

<u>Answer</u>

- The Draft Structure Plan will include proper planning practice to identify the new township boundary for Romsey. In the first instance the detailed analysis will be undertaken for infill development and then further growth to the south of Romsey.
- 2. The Draft Structure Plan will include proper planning practice to identify the new township boundary for Romsey.
- 3. Councillors have access to all submissions provided as part of the Emerging Options Paper.

7.9 QUESTION PROVIDED BY MEMBER OF THE PUBLIC

Why if the town's residents have overwhelmingly stated through the submission process that they do not wish for the town boundary's to change is the council pushing ahead with the large district town? Can the Macedon Ranges Planning Scheme be amended to reflect the fact that the residents of Romsey and surrounds do not wish for Romsey to be a large district town?

Answer

The 'large district town' designation has been set since 2011 by the Settlement Strategy for Macedon Ranges, and more recently by the Victorian State Government's Macedon Ranges Statement of Planning Policy (2019), and is included in the Planning Scheme.

Given the direction from state government it is unlikely that a change in the Macedon Ranges settlement hierarchy would be supported by the Minister for Planning.

7.10 QUESTION PROVIDED BY MEMBER OF THE PUBLIC

We are seeking clarification on the statement on page 21, to "Review minimal easterly growth south of Romsey Road"

If it has been determined that south of Romsey is the preferred greenfield expansion option, why is any easterly growth necessary? Will development within the existing town boundary, along with greenfield expansion south of Romsey, not provide for sufficient growth?

What are the benefits of easterly growth to the community, and how will it improve the character and environmental qualities of Romsey? Do those benefits outweigh the negatives, such as:

- higher levels of traffic congestion through the main township
- reduction of the rural break between Romsey and Wallan
- erosion of township character and rural feel
- impact on the visual and environmental setting of the township
- loss of rural land and natural resources and features
- requirement for extensive new (and expensive) infrastructure?

Answer

The area identified in Action 56 reads as follows:

Review minimal easterly growth south of Romsey Road to ensure suitable township interfaces and bushfire buffers are created but avoid impacting on the Romsey Water Treatment Plant buffer areas.

This statement is intending to ensure that growth in the south area is congisnet to the Water Treatment Plant as well as bushfire risk and its interface with other residential areas.

The statement is referring to the south land, not the "easterly" north of Romsey Road.

Council will undertake a further detailed analysis of growth scenarios through the Draft Structure Plan Process. This work is underway and is expected in early to mid 2023.

7.11 QUESTION PROVIDED BY PATRICK FRANCIS

Before Council endorses the Romsey Emerging Options Paper Consultation Summary Report will it release to the Romsey community and rate payers the modelling undertaken by its own planners and/or P2P which estimates annual greenhouse gas emissions generated between 2021 and 2041 associated with the proposed increases in population, development and housing for each of the three Scenarios described in Figure 25 of the Draft Romsey Structure Plan . And by what percentage or annual amount each year to 2041 will Council's strategies as a founding partner to the TAKE2 pledge program to achieve emissions reductions targets, reduce each of the three Scenarios greenhouse gas emissions totals to meet its own, the state's and the federal government's target of zero net emissions polices by 2050?

As background to this question the Draft Romsey Structure Plan's summary document for Sustainability and Resilience states "six opportunities have been developed that would provide a range of benefits to the town related to ...lower greenhouse gas emissions...". But there is no data or reference to find out the quantitative context for "lower greenhouse

gas emissions" other than a general statement that "with new development being connected only to electricity infrastructure and not gas". This statement does not reflect the additional amounts of greenhouse gases generated from all sources associated with each of the three scenarios to 2041. Council's own Climate Change Action Plan 2017 documents states "Promote the vision of a zero net emissions shire by 2050 as a shared council-community vision, consistent with the state government target for a zero net emissions Victoria."

Answer

No greenhouse gas modelling was undertaken as part options provided in the Romsey Emerging Option Paper. Any modelling would be heavily reliant on 'assumptions' and projected behaviour change.

The Environment Strategy Refresh 2021 identified a Zero Net Emissions Plan for Council Operations to be prepared. The plan will consider how best to monitor and mitigate Council's increased emissions relating to urban development such as lighting, waste collection (and disposal) etc.

7.12 QUESTION PROVIDED BY SHAUNA MARTIN

With regards to the Romsey Structure plan, with 62% of the results of the survey showing people want either option 1 growth within the current boundary or prefer no growth, why is the Council insistent on pursuing development to the south and east considering all the concerns raised in the detailed submissions. Are the Council asking the community for feedback and still going to actively ignore it for their own gains, many of whom do not live in Romsey?

Answer

The role of Romsey as a large district town has been identified in state and local policies as a large district town which can sustain a smaller level of growth compared to the regional centres of Gisborne and Kyneton. Council's Settlement Strategy and the Macedon Ranges Statement of Planning Policy (SPP) underwent significant community consultation.

The development of these policies identified the need for a revised Structure Plan that includes sufficient land to accommodate growth while also protecting Romsey's neighbourhood character and key agricultural areas. It is not the role of the Structure Plan to change or alter the position of Romsey within the Macedon Ranges settlement hierarchy.

Council is committed to the preparation of a Draft Structure plan that responds to Council's existing policies as well as feedback provided by the community.
