### **Conditions of Use**

## General

- The Hanging Rock Recreation Reserve is self-funded and unfortunately receives no State or Local Government operational funding. It is therefore necessary to charge entry fees which enable the ongoing operation, care and development of Hanging Rock.
- The Annual Pass is for personal use only. It is not to be used for commercial purposes. Failure to adhere to this condition will result in the cancellation of your Annual Pass.
- The Annual Pass is not transferable and should only be used by the applicant or persons within the applicant's household.
- Applications will not be considered where conditions of use have previously not been adhered to.
- The access card remains the property of Macedon Ranges Shire Council.
- A limit of 1 access card per applicant applies.
- No refunds will be given for the cancellation of an Annual Pass.
- The Annual Pass is not valid on major event days.

#### **Annual Pass Term and Fees:**

- The Annual Pass is valid for the 12 month period from 1 July 2024 to 30 June 2025.
- The Annual Pass fee is payable prior to an Annual Pass being issued.
- Should an application for an Annual Pass be made part way through the year the fee will be charged on a pro-rata basis (see below).
- Should an applicant lose their access card, a fee of \$12 will apply for a replacement access card.

#### **Fees**

If the pass is purchased:

<ul> <li>between 1 Oct 2025–31 Dec 2025:</li> </ul>	\$67.50
<ul> <li>between 1 Jan 2026–30 Apr 2026:</li> </ul>	\$45
<ul> <li>between 1 May 2026–30 June 2027 (valid for 14 months):</li> </ul>	\$90
